## GLEANINGS FROM THE SUNDAY BULLETIN

### PASTOR'S THOUGHTS...



*Fr. Mario Micallef, MSSP, is pastor of St. Paul the Apostle, Toronto, the only Maltese national parish in North America. These "Pastor's thoughts..." are extracts from his commentaries on the Sunday readings which are published in the Parish's Sunday Bulletin.*

#### Do Rich People Go to Heaven?

I heard someone ask this question once, apparently sparked by the importance the gospel seems to give to the poor. Before going any further, it's important to remind ourselves from the beginning that nobody, absolutely nobody, is denied the possibility to go to heaven. [A] passport to heaven is not based on social status or one's bank account. What matters is what we do with what we got....

Sometimes we might think that to hate someone is the worst evil we can do. I strongly believe that indifference is worse than hatred! When you hate someone, you are at least acknowledging that person's existence, giving him some importance in your life. When you are indifferent to someone, on the other hand, it is as if that person didn't even exist for you. You are depriving him not only of love and attention, but even from the very right to exist! Like the rich person in the [gospel] parable, you would be closing yourself up in your own mansion, totally oblivious to the other person at your doorstep.

Indeed, the problem is not money or riches. The real question is, "What do I do with what I have?" do I lock myself up in my own little mansion? Or do I use what has been given to me to help others?

#### A True Follower of Jesus

....A true follower of Jesus does nothing because he is forced, simply out of obedience or because it is his duty. This brings no joy. Everything a true follower of

Christ does is done out of love, because that is what Jesus did. St. Paul, the strict pharisee who eventually met Jesus on that fateful day on the road to Damascus, could reflect and compare his past and present life, the "old" and the "new" man, life under the law and life under the Spirit. Only the latter brought Paul life and happiness.

#### True Healing

The healed leper [in St. Luke's gospel] did not continue on his way [after being healed]. The most important thing for him now is to return to the one who gave him back his life. This is what real faith is all about. It is not merely doing what one is expected to do by law. It is a desire to encounter Jesus acknowledging that what is good comes from Him. This encounter with Jesus becomes more important than anything else. No wonder that, in the end, Jesus tells him that now he can go on his way: "Your faith has made you well."

True healing is not just the healing of bodily illness. It is a constant return to Jesus, an acknowledgement that only He can give us the fullness of life that we all desire.

#### Prayer Is My Relationship with God

....When we talk about prayer we are not merely referring to the formal prayers which we learn by heart. It is a way of living, an attitude which we develop in our life. Prayer is my relationship with God. Like any other loving relationship, it is not merely made up of formal petitions of beautiful talk. It is, rather, being there for and with the other. It is having the other constantly present in one's mind and heart. Like any other relationship, it either grows or dies out as time goes by. It's a dynamic relationship, and never stays the same. When Paul, in one of his letters to the Thessalonians, tells us to "pray without ceasing," he is not telling us to be constantly on our knees, or in church, or reading our prayer books 24 hours a day! He is, rather, urging us to enter into his loving relationship with God, to never give up even when the "other" seems silent or aloof, or perhaps when our well seems to have run dry.

## **AN EXAMINATION OF DATA FROM MALTESE BILLS OF HEALTH AND PASSPORT APPLICATIONS HELD AT THE NATIONAL ARCHIVES OF MALTA**

### **PART I**

*Editor's note: Mark Caruana is no stranger to the pages of this journal. In addition, many references have been made to his work, particularly for Canada and the United States, on passenger lists compiled at the ports of disembarkation for those of Maltese birth or blood.*

*This article introduces you to the work he has been doing on Maltese bills of health and passport applications and how, like such resources as Charles Said-Vassallo's online [maltagenealogy.com](http://maltagenealogy.com), this could help you in tracking down a long-lost relative or adding to your family research.*

*As a specific example of the usefulness of the research Mark describes in this first part, some time ago I asked him if Louis Shickluna's name might be among the 64,000 bills of health generated between 1815 and 1850. Within minutes, and from a half-world away, Mark was able to provide me with data on two bills of health possibly for the first Maltese known to have settled in Canada.*

### **An Overview:**

This article outlines an on-going voluntary effort by one individual, namely myself, working half way around the world from the original documents, to build, to date, a database that supports the content analysis of a collection of Maltese bills of health from 1815-50 and passport applications and renewals from 1870 to 1937. Data entries for 1938-39 are presently on-going.

It is said the bills of health and passport applications and renewals were once “*stored or dumped in the lower part of Fort St Elmo*” before being rescued and transferred to the National Archives of Malta (NAM) and that while in this fort, many were cut up and used for carnival floats for the annual *Karnival*. This may explain why the bills of health or passport applications and renewals, as the case may be, covering the years 1850-1870 and the passport applications and renewals for the years 1872-1886 are not to be found at the NAM.

What I am attempting to do is address the need of such a digital resource as the database on which I am working; the process of its development; its structure and its possible applications in research.

The work itself has taken over 10 years and is an example of an effort by a private individual. This article in a different format was first presented as an academic paper to the wider community in *New Review of Information Networking*, vol. 21, no. 1 (2016) pages 52-62 and was read at a symposium in Malta that same year. This generated database is particularly useful for anyone interested in studying the Maltese diaspora.

### The Need for a Digitalized Database

My visit to the NAM in 1999 to search for documentary material on Maltese migration to Australia led me to the realization that the NAM held a vast collection of unindexed bills of health and passport applications, stored in ledgers and pamphlet boxes, on rows of endless shelves.

I then requested photocopies of those passport applications where the destination stated was Australia. On my return to Sydney, I started entering the information as a Microsoft Access database. This work gradually developed to include all surviving Maltese bills of health and passport applications issued, as described below in the “Development and Use of the Database” section of this article.

When I finished entering these data, a new vista opened up to me of patterns of migration, such as family reunion, chain migration of persons from the same village, returned migrants, applications for a passport from a person of Maltese blood in the diaspora whose father was born in Malta, and so forth. Some names of migrants were familiar to me as I had previously done oral history interviews with a number of them. The database with this passport information enhanced and confirmed the dates given to me from oral history memories.

I restricted the data I recorded from the passport applications to a relatively simple database of 13 fields, namely passport number, date of issue of passport, surname, given name, relationship of applicant, age, occupation, date of birth, town or village of birth, current residence, destination, and a “Remarks” column. The data included applicants from Malta and its diaspora,

whether migrants, students, merchants, British service people, mariners, and other nationalities, among others.

To date, the total number of entries has reached 74,000 surviving passport applications and renewals covering a 67-year period from 1870 to 1937. The project also includes a database of 64,000 surviving bills of health (1815-50) and 4,500 seaman’s certificates. The total number of entries has now reached some 143,000 individuals.

Around the year 2004, the NAM digitized its bills of health and passport applications. Although these were now digitized, they were an unindexed resource without an aid of some sort which would allow a person to quickly search for names, locations or other data from the applications. These needed indexes for quick reference and my database met this need.

Four years later, the National archivist Dr. Charles Farrugia approved a data entry project of all digitized bills of health and passports on a Microsoft Access database. It was envisaged that the database will be fully completed by entering remaining passport data till early 1940, when the last boat to Australia left Malta immediately after the outbreak of war there. The war years made travelling a risky undertaking and very few passports were issued. Post-war passports were years of the beginning of mass migration to distant lands and they require a designated project on data entry.

### Development and Use of the Database

As already mentioned, the primary sources that were used to generate information for the database included bills of health and passport applications.

Bills of health pre-date passport applications. The first bills of health were recorded in 1815, more than 200 years ago, and were 225 in number that year, but the data entered then was very brief: name, surname, year, month, and day of application for a bill of health and some information in the remarks column. From this last entry, one gathers if the applicant were exempt from paying the fee (noted as “gratis” and this was mainly to religious persons or high-ranking authorities) and whether the applicant was the wife or the children of the principal applicant.

From 1836-50, the bills of health expanded the data required and added the destination of the applicant.

Some bills of health have useful information, as when an applicant became naturalized or a citizen of the Maltese Islands, like a Ghio Giuseppe in 1818 (see

Table 1). One may surmise that the first Ghio in Malta was accepted as a Malta citizen in that year and he was from the port city of Genoa, Italy.

This additional “Remarks” entry is a very useful addition for Maltese living in its diaspora, as it identifies the name of the pioneer applicant, how many left Malta that year, to which destination, and so forth. For example, one can deduce, from the frequent family trips to Girgenti that the surname Albanese originated from Girgenti, Sicily, as multiple entries are listed for a number of Albanese applicants, whose destination invariably was Girgenti. The Albanese applicants seem to have had a respectable rank or position in society as the title Mr or Signore is added after the name.

## Dr. JOSEF BUTTIGIEG AND HIS WORK IN THE FIELD OF MULTIPLE SCLEROSIS

Dr. Josef “Jo” Buttigieg is a neurophysiologist in the Department of Biology at the University of Regina in Saskatchewan, Canada. He earned at PhD in neurophysiology, in 2009 with Dr. Colin Nurse at McMaster University in Hamilton, Ontario. This was followed with a post-doctoral fellowship under the supervision of Dr. Michael Fehlings at the University Health Network in Toronto. Since September 2011, Dr. Buttigieg has been at the University of Regina where he is currently an assistant professor.

Canada is among the countries having the highest rate of Multiple Sclerosis (MS) in the world. And Saskatchewan has the highest number of cases in the country. It's a disease that Dr. Buttigieg and his team is studying.

MS is an autoimmune disease in which one’s immune system begins to think its own body is a foreign substance and starts to destroy it. Specifically, the disease attacks myelin, an insulating layer or sheath that forms around nerves, including those in the brain and spinal cord. This sheath allows electrical impulses to transmit quickly and efficiently along the nerve cells. The end result of destroying that insulation is that it causes the neurons to short circuit and then that leads to numbness in a limb, paralysis, cognitive and vision loss and, for many people, eventual death.

What Dr. Buttigieg and his team are working on is the development of a “Trojan horse” against MS.

The concept harks back to Greek mythology to the time of the Trojan War when the Greeks constructed a huge wooden horse, pretended to abandon their assault on Troy and left the horse as an offering to Athena (goddess of war) which would make Troy impregnable. The horse was taken inside the city gates

and during the night the Greek warriors inside it emerged and opened the gates to let in the returned Greek army.

What Dr. Buttigieg and his team have developed is similar in concept. MS looks for a specific protein that's in the insulation of a person's neuron. Buttigieg's team have been experimenting with mice. In one experiment it gave the immune system of a mouse having MS that protein, but with a twist. Tied to the protein were two others, one of which kills the immune cell that is attacking the myelin.

The mouse in question could not move its hind legs or walk and had only partial movement of its front legs before beginning the treatment.



Four days after the above photograph was taken, the mouse could fully walk with all four legs after being treated with the "Trojan Horse" protein.



The team was giving the MS the protein that it wanted but what it didn't know was that there's a bomb hiding inside this protein. Once the cause of the problem was eliminated, the body then had an opportunity to repair itself and the team could see that the myelin sheath of the neurons had been repaired.

Since the project was begun in August 2018, the process has been repeated several times with mice being in severe stages of MS. Within a few weeks the mice have been starting to walk again.

With these promising results, Buttigieg hopes to have a clinical trial soon. First, the team plans to test the treatment on patients' blood. People who have multiple sclerosis have donated blood for the team to see how the immune system in the blood reacts to the proteins.


In early October of this year, Dr. Buttigieg said his "dream time" to start clinical trials would be tomorrow. But that depends on a number of things, he said, including support from the public, support from the government, and funding.

For those suffering from this disease or having loved ones or friends with MS, the clinical trials can't start soon enough.

### MALTA ABROAD—MELITA, MANITOBA\*

The town of Melita is located in southwestern Manitoba, 37 km (23 miles) east of the Saskatchewan border. Its current population is 1,042 (2016 census). The first recorded European settler was Charles West, in 1879. Its first post office was established in 1884.

The late Betty Fox, cancer advocacy champion and mother of the late Terry Fox, was raised in Melita.

The early inhabitants chose the name "Melita" for the town after hearing a Bible reading about St. Paul's ship wreck on the island of Malta. (Acts 28:1) "*Melita*" is the Latin word for "Malta," and was derived from the Greek word "*Melité*" for the island, meaning "honey-sweet," possibly owing to Malta's unique production of honey.

On the other hand, there are those who believe that Malta is derived from the Phoenician word "*Malet*," meaning "a haven," in reference to Malta's many bays and coves.

Paul Gauci immigrated to Canada from Cospicua, Malta in 1966 to be reunited with his five children. Within a few years, the Maltese Canadian Society of Toronto organized a marching band under the direction of Mro. Paul Gauci. "For three years this band performed for the community and at various MCST events. In 1971 the band members decided to branch out on their own and formed the now popular and successful Malta Band Club, Inc."

### **NICK PULIS: A UNIFYING FACTOR IN THE JUNCTION\***

That's how Chev. Nick Pulis, B.A., Ph.D. O.S.J. always wanted to be known, called, and remembered...just "NICK PULIS."

Though a bright, intelligent and highly educated man, the very fact that he honestly and genuinely considered himself one of the crowd, an ordinary person of no

consequence, manifestly shows an evangelical simplicity he cherished all his life – a simplicity that turned him into a true Christian, and hence, through his good works and love of neighbour, he spread Christ's message all around him.

A couple of weeks before he passed away, he told a number of relatives and friends surrounding his death-bed: "I have never had any worldly ambitions...I have never been attached to this world or any of its illusions...I look upon death as the beginning of life and not as its end."

And as if this spontaneous revelation of his inner self were not enough, sometime later, he asked a member of his immediate family to hand him the Summer issue of FORUM MELITENSE, and, slowly but steadily, he jotted down the following message on FORUM's large brown envelope: "September 1977 – Between the hours of 9 and 10 a.m. this month I will be in the next world where I will start a new life. I have endured much physical pain. I now await death happily and joyfully. I thank all my friends; and may they always remember me as Nick. Release this my last message for publication in FORMUM MELITENSE – Nick Pulis."

Mr. Nicholas Pulis was born on 29<sup>th</sup> May, 1917 at the picturesque village of Siggiewi, Malta. On 6<sup>th</sup> January 1940, he married Josephine, nee Azzopardi who hailed from Rabat, Malta. He left to mourn his loss four children: Mrs. Doris Dimech, Anthony, Mrs. Carmen Lockhead, and Joseph; and two granddaughters: Brigida and Lisa Ann.

In Malta, Mr. Pulis worked for many years at the Cathedral in Mdina, and soon, he became very knowledgeable in its history and in that of the city itself, which up to the building of Valletta in 1566, was the capital city of the Island of Malta.

He came to Canada on 8<sup>th</sup> December, 1950, and settled in Toronto in the Dundas Street West area, where he lived until his untimely demise. Full of life and initiative, he dedicated all his spare time to the betterment of the Maltese Community spread around its national church of St. Paul the Apostle.

It was at about this time that, with the help of four other compatriots and that of Mr. Patrick Cameron, Q.C., the lawyer of the MALTESE-CANADIAN SOCIETY OF TORONTO, he assisted in clearing newly arrived Maltese from the centre at Ajax, Ontario, where newcomers from Malta used to be temporarily placed. The conditions there, however, were such that trouble soon developed in the compound.

One of the greatest difficulties facing Maltese coming to Toronto, especially when emigration from Malta had become rather heavy, consisted chiefly in their finding board and lodging, as well as employment at the earliest possible time. This difficult situation of uprooted humans required people willing to sacrifice the comfort of their homes and their rest after a day's work, and

without ifs or buts, be up and doing to give a helping hand to their less fortunate brethren. Nick Pulis met the challenge with patriotic and humanitarian zest. Never has one man done so much for so many!

Even though this phase of his life bordered on the public domain, yet he had always insisted with me never to reveal the specific details of his outstanding endeavours during that period. I shall, therefore, refrain from dwelling any longer on this subject.

On the occasion of the Coronation of Her Majesty Queen Elizabeth II, Nick Pulis was one of the principal organizers of the Coronation Parade, in which the MALTESE-CANADIAN SOCIETY OF TORONTO fully participated.

He was already in his late forties or so, when he made up his mind to upgrade his education. Overcoming the time-factor problem which his employ for 26 years at the Canadian Imperial Bank of Commerce presented, he managed to find time for his courses and successfully obtained his B.A., and finally, his Doctorate in Philosophy (Ph.D.) at the University of Toronto. It was only after he had passed away that the majority of the Maltese Community became aware of his scholarly achievements so late in life. In the circumstances, the adage "It's never too late to start!" was once more proven correct.

In recognition of his selfless dedication for the welfare of others, the Sovereign Order of Saint John of Jerusalem \*Knights of Malta\* conferred on him the coveted title of KNIGHT. Chev. Nick Pulis was officially invested as Knight of Malta on 31<sup>st</sup> August, 1968 by the Rev. Fr. Laurence Bonavia, O.F.M., P.E.P., O.S.J., at the Maltese Church of St. Paul the Apostle in Toronto of which Fr. Bonavia was the pastor. On 29<sup>th</sup> June, 1977, Baron Michael Vella Haber, the Grand Prior of the International Order of St. John of Jerusalem \*Knight of Malta\* (World Headquarters, at Gzira, Malta), bestowed on Kt. Nick Pulis the rank and title of Knight Commander of Justice, and appointed him head of the Commandery of Toronto.

Unity, co-operation and understanding among all Maltese organizations in Toronto and its vicinity seemed to have been his most vehement aspiration in life. In that view, he made it a point to become life member of several associations, notably of the MALTESE-CANADIAN SOCIETY OF TORONTO, the MELITA SOCCER CLUB, the MALTESE PROGRAMME FAN CLUB & the MALTESE UNITY ASSOCIATION OF CANADA, Inc.

In other various ways, Nick Pulis gave full support, practically, to all the Maltese Organizations he knew. To some he presented either the Maltese or Canadian flag; to others who requested, he donated a standard displaying the official emblem of the respective organization. To the Maltese-Canadian Society of Toronto, he gave, among other items, the cape and

scepter of Miss Malta of Toronto.

As a great believer in the importance of the Maltese press for our immigrants, Nick Pulis was a staunch supporter of FORUM MELITENSE and one of its exceptional collaborators and benefactors.

Thus, Nick Pulis became a unifying factor in the Junction [the main intersection of which is Dundas Street West and Keele Street] and elsewhere in Canada and the U.S.A., and by the very fact a leader in his own right of the Maltese community.

When Dr. Chev. Nick Pulis breathed his last on 16<sup>th</sup> September, 1977, many were those who sorrowfully expressed their admiration for him in simple but profoundly meaningful terms: "The Maltese Community has indeed lost a corner-stone in its structure very hard to replace in the future."

And now that Nick Pulis is no longer physically with us, we should all feel it our duty to heed Saint Ambrose's advice: "We have loved him during life: let us not abandon him until we have conducted him by our prayers into the house of the Lord."

### New York City

Most of the Maltese-born currently living in New York, and mainly from Gozo, arrived some 30-40 years ago. With their children and grandchildren, it is estimated

that some 40,000 persons of Maltese birth and blood live in the New York area.

The Ministry of Foreign Affairs is working hard at the diplomatic level for Malta to be elected for two years to serve as a non-permanent member of the UN Security Council. The Government is also looking for a more suitable and spacious place for Malta's mission to the UN. Malta's current embassy, originally a house, was purchased in the 1970s and is on the other side of New York rather than within a one km radius of the UN headquarters as are most of the world's embassies.

While at the open house held on Wednesday, September 26<sup>th</sup>, Prime Minister Joseph Muscat spoke about plans for Air Malta to start operating flights to New York and promised that he would be back to NYC next year. (See front cover)

### COUNCIL OF MALTESE LIVING ABROAD MEETS TO DISCUSS PRESSING COMMUNITY ISSUES

Issues, ranging from teaching the Maltese language outside of Malta to the possibility of a birthright program for young people to visit Malta, were discussed at the 10<sup>th</sup> meeting of the Council of Maltese Living Abroad (CLMA) held October 10<sup>th</sup>-11<sup>th</sup> in Valletta.

The CMLA is comprised of 15 representatives from Maltese communities abroad, including Canada and the United States and is chaired (ex-officio) by Carmelo Abela, the Minister for Foreign Affairs and Trade Promotion. Members are selected for three-year terms and meet once a year in Malta.

Canadians are represented by Sue Schembri from British Columbia and Branden Azzopardi from Ontario and individuals from the United States by Claudia M. Caruana from New York and Angelo Grima from Washington, D.C.

The Council was established by means of Act XX of 2011 following the Emigration Conventions organized in 1969, 2000, and 2010 that recommended the

establishment of a council composed of representatives of Maltese communities and others with the aim of promoting the rights and interests of Maltese living

abroad.

According to its mandate, CLMA represents the Maltese Diaspora in meetings with the Maltese government and public authorities. It monitors the standard of living of these Maltese communities abroad and works to strengthen the links among them and the political, cultural, economic and social aspects of Malta. At a press conference held immediately after the conclusion of the meeting, Foreign Minister Abela referred to the several issues that have been discussed: the review of Act XX of 2011 to regulate the Council; changing culture programs; registration of property which the Maltese living outside the Maltese Islands have; the subtitles for Maltese productions; matters relating to Maltese identity; ways on how to better engage with the Maltese Diaspora; and the establishment of Regional Committees.

“The Maltese Council for Maltese that live abroad also can be considered as the official vehicle carrying ideas that promote the rights and interests outside Malta, with a view that, where possible, to be implemented by the Central Government,” Dr. Abela stated.

Minister Abela also spoke about the concept of a global Malta in a globalised world, as the way to look at the Maltese diaspora in the coming years.

He stressed: “There is no ‘us’ and ‘them’, our interests and theirs, but a common interest to boost Malta’s uniqueness.”

Below is a summary of the CLMA’s work during this session:

**Outcomes include:**

- Teaching of the Maltese language will soon be available online, through the creation of an online digital platform, a project which is being carried out through the Ministry for Education and Employment which has now passed into the tender preparation phase (time frame for implementation end of 2020);
- English subtitles for some of the production by the Public Broadcasting Services were provided. PBS is working on new productions which will also have English subtitles available;
- The completion of a Code of Ethics for members of the Council of Maltese Living Abroad, and
- The launch of Regional Committees.

**Matters discussed**

- The review of Act XX of 2011 to regulate the Council;
- Exchanging culture programs;
- Registration of property which the Maltese living outside the Maltese Islands have;
- Subtitles of Maltese broadcast productions, including the news;
- Matters relating to Maltese identity,

- Ways how to better engage with Maltese Diaspora;
- The implementation of Regional Committees.

**Decisions and Outcomes**

- **Cultural Exchange Programme for the Maltese Diaspora** –

The Ministry for Foreign Affairs and Trade Promotion will act as a liaison between Maltese Living Abroad and the Arts Council Malta and its sister institutions, in an effort to import and export cultural projects.

- **Registration of Property Online with the Planning Authority** –

To request the Planning Authority to provide for a system through which Maltese living abroad will be informed formally about any development application on property in which they have a vested right.

- **English Subtitles of Maltese Media for overseas distribution** –

Public Broadcasting Service (PBS) will be considering the proposal of the subtitling of weekly news in English (which is sent to Australia and Canada) as well as in French.

- **e-ID to Maltese Diaspora to access info.mygo / ID Card for Maltese Living Abroad** –

Identity Malta will be considering a means of providing Maltese Living Abroad with access to Servizz.gov, possible through a digital ID.

- **Citizenship Law Amendments** –

Identity Malta will consider questions raised during the discussion and revert back to us.

- **Heritage Malta Senior Passport** –

Maltese living abroad visiting Malta can apply for this passport by visiting the local Council accompanied by a relative, presenting their passport (visitor’s) and with the relative consent using his/her address.

**Updating ACT XX of 2011** –

All stake holders, including the Opposition, will be involved in the review of the Act.

- **Establishing a system to help Maltese Living Abroad who were affected by the close of Maltese Bank offices in their countries** –

The Bank of Valletta representative informed the Council that the Bank will reopen, upon request, all accounts of Maltese citizens living in Malta who were born in Malta and hold a valid Maltese passport. The Bank has no choice but to ask for all compliance documentation on a regular basis from their clients for the latter’s accounts to remain active

with the Bank.

- **Commemorating the Maltese Emigrants** –  
The Council decided on considering the proposal of a monument for commemorating migrants, possibly on the Exodus wall.
- **Maltese Birthright Programme** –  
The Council will consider any specific proposals from members about the setting up of a Maltese Birthright Programme for providing Maltese youth living abroad to visit Malta to connect with their roots.
- **Suggestions from Committee members how to approach the younger generation (2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> generation) being culture, arts, etc.)** –  
The main suggestion was to set up a website and a social media platform. This proposal is under consideration. For the time being, the Council agreed to keep the platform within the Ministry's own website and consider placing it in a more visible place in the near future. With regard to the setting up of a separate website for the Maltese Living Abroad, an expression of interest to interested suppliers would have to be issued according to government procedures.
- **Digital platform for the teaching of Maltese language)**–  
Council was updated about this platform; implementation is in an advanced stage.

## MALTA'S 5<sup>TH</sup> EMIGRANTS CONVENTION ANNOUNCED

'Keeping Connected'--A convention for Maltese Living Abroad is scheduled for October 5-10, 2020 in Malta. Prior conventions held in Malta focusing on Maltese emigrant concerns took place in 1969, 2000, 2010 and 2015.

Preliminary information released from the Ministry of Foreign Affairs at a press conference at the conclusion of the Council for Maltese Living Abroad meeting last month, focuses on a format, different from prior conventions, that will include workshops on ways the interests of the Maltese diaspora abroad can be protected.

Convention planners also are looking at programming sessions on ways second, third, and fourth generation Maltese can become more involved in celebrating and learning more about their heritage.

A cultural program of Maltese art and literature also is being planned.

The call for proposals/presentations has been issued with a deadline for submissions set for January 10, 2020.

The actual venue in Malta for the convention has yet to be announced.

**MEET THE MALTA BAKE SHOP'S OLDEST CUSTOMER**

On Sunday, October 6<sup>th</sup>, Dr. Raymond Xerri had an opportunity to chat with Mr. Kalcidonju Tanti at the Malta Bake Shop in Toronto's "Malta Village" on Dundas Street.

Tanti, a widower, said he never misses a day coming to the Bake Shop for a coffee and pastizz and regards his fellow customers as family to whom he speaks "and offers helpful life wisdom and guidance."

He remembers when the nearby St. Paul the Apostle Church was but a basement church.

Tanti, now 91 years of age, was born on October 2, 1928, in Rabat, Malta.

He boarded the Greek ship the *Nea Hellas*, in the Grand Harbour on Tuesday, April 20, 1954 and disembarked at Halifax on May 2<sup>nd</sup>. He then travelled by train to Toronto.

"Uncle Calci" recalls that he was not scheduled to leave on the *Nea Hellas*, but someone cancelled out and the police went to his door on Monday, April 19<sup>th</sup> to ask if he were willing to depart for Canada the next day.

Such sudden change of plans were not uncommon at the time, I know of an entire family who came to London, Ontario from Malta and who had less than 24 hours to finish packing and get on the ship which was leaving the next day.
