GLEANINGS FROM THE SUNDAY BULLETIN

PASTOR'S THOUGHTS...



Fr. Mario Micallef, MSSP, is pastor of St. Paul the Apostle, Toronto, the only Maltese national parish in North America. These "Pastor's thoughts..." are extracts from his commentaries on the Sunday readings which are published in the Parish's Sunday Bulletin.

"God, Be Merciful to Me, a Sinner"

The tax-collector's prayer is praised by Jesus. Eventually it became one of the most famous and used prayers throughout the centuries. The monastic Desert Fathers and Desert Mothers used it as early as the fifth century, invoking Jesus' mercy by repeating in the form of a litany phrases like, "Lord Jesus, have mercy on me a sinner."....

As we continue to journey with Jesus throughout the gospel of Luke, it would be a good...to listen to the way we pray. How do I come into God's presence? Where is the focus of my thoughts during my prayer-time? Am I concerned to prove how good I am, or do I express my need of God's continuous mercy in my life? Where do I see myself more in the picture painted to us by Jesus in...[His] parable: close to the pharisee or at the back of the Temple with the tax-collector, humbly asking God's mercy?

Are We Like Zaccheus?

In a way, Zaccheus' story can be the story of each and every one of us. Who of us can say that we have not been hindered at some stage of our lives by our smallness in our journey with the Lord? We are painfully aware of our smallness, of our unworthiness, of our not being up to standard. Somehow, the truth of what we pray before communion, "Lord, I am not worthy," becomes an obstacle rather than a spring-board to thrust ourselves into God's merciful arms.

Then there is the crowd. When following Jesus implies

having to go against the current, we immediately feel that we have to conform, to join, to not be different. The fear that we might be ridiculed or having to stand out is very real....

Unlike the other "good" people who started grumbling against Jesus for going to the sinner, Jesus is not scandalized by our unworthiness. Just accept Jesus' invitation to come and visit you, and allow the rest to happen.

Our God Is God of Persons

Our God is not a generic god, or a God of some theory or ideology. He is God of persons, of real human beings. the God of Abraham and Isaac and Jacob, the God of Jesus Christ is the God of Jane and Peter and Mary and Paul. God is God to of each one of us. He longs to enter into a personal relationship with each one of us. And this, my friends, in the source of our joys and our hopes. This is where eternal life comes from.

We Are Being Carried in Safe Hands

....There had been people who tried to "predict" the end of the world. Jesus warned that there will even be many more who will try to do the same. Even in our own times, in fact, we know that there are people who will still try to do this. Some sects have been predicting the end of time over and over again. and we all remember how terrified many people were as the year 2000 approached! Jesus tells us not to worry about all this. There will be wars and natural disasters, but that will not be the end. It is not up to us to know when the end will come. What really matters for us is to live as best we can the life which we have here.

This will not be always easy. As happened to Jesus, there will be times when we will have to suffer in order to do the right thing. Today like in Jesus' time, his message is not welcomed by everyone. Here Jesus encourages us by letting us know that, in all this, we will be well taken care of by God. He is Lord of Time, of history, of our lives. What really matters for us is that we make the most of our time here on earth, persevering in times of trial, knowing that we are being carried in safe hands.

MISS MALTA PAGEANT EXHIBIT

This striking exhibit of the Maltese-Canadian Society of Toronto (M.C.S.T.) "Miss Malta Pageant" was arranged by Rose Cassar, Carmen Galea, Rita Kennie and Mani Mifsud, dedicated volunteers at the Maltese-Canadian Museum/Archives at St. Paul the Apostle Church Complex, Toronto, where this exhibit is housed.

The red cape trimmed with authentic ermine and the scepter were donated by Chev. Nicholas Pulis in 1967. The silver-plated annual trophy was donated by Mr. Joseph Vassallo, the son of one of the Society founders and former owner of Magneto Electrical Company. Sadly, that trophy has gone missing when the M.C.S.T. closed.

The Pageant was an event started by M.C.S.T. President Frank Savona, O.S.J. as part of the Maltese community's celebration of Canada's Centennial 1867-1967.

Initially, the Pageant was called "Miss Malta of Toronto", then in later years the committee of the M.C.S.T. changed the name to the "Miss Malta of Canada Pageant." The name "Miss Malta Pageant" was registered owing to the Miss Malta contest of Malta, established in 1963 by the late George and Deggie Gatt Mangion as GM Productions.

The Miss Malta of Canada Pageant was such a popular event that it was held annually by the Society for the next 40 years. The Pageant always took place in November, so that the new Miss Malta could start her reign in time for the Christmas events that were held at the Society. In latter years the M.C.S.T.'s Miss Malta was often invited to attend events of other Maltese organizations for example the then Federation of Maltese Organizations (now Maltese-Canadian Fede-

ration) annual seniors Christmas Dinner at St. Paul's Church Hall.

From 1971 until about 1975, I used to have to walk each contestant down the runway, at times I was more nervous than the contestants. It was always my job to select the three judges; their names were kept in strict confidence until the day of the pageant.

The selection of Miss Malta was based on poise, intellect and knowledge of Malta's culture and history. Most Maltese businesses donated gifts to be used as prizes, first prize was a trip to Malta donated by Melita Travel Service.

The Pageant was always held under the distinguished patronage of a noted individual. Among many "masters/mistresses of ceremony" over the years were Gina Hili with comedian Johnny Catania, singer Enzo Gusman and producer Tony Parnis.

The colourful event became a major attraction within the community, usually drawing an attendance of 350 to 500 individuals. A dinner/dance took place after the Pageant and the pastor of St. Paul's was present to say grace.

At some of these pageants a few contestants found their future spouses. Many life-long friendships were made and the contestants always supported each other. It was a fun-filled and exciting event.

AN EXAMINATION OF DATA FROM MALTESE BILLS OF HEALTH AND PASSPORT APPLICATIONS HELD AT THE NATIONAL ARCHIVES OF MALTA

PART II

Editor's note: In Part I, Mark gave an overview of his work in building up a database on the existing bills of health and the passport applications to the end of 1937. He then presented the need for such a database, the fields selected and an introduction to the bills of health. Part II introduces us to the evolution of the passport applications from 1870 until at least 1937.

Development and Use of the Database

As already mentioned, the primary sources that were used to generate information for the database included bills of health and passport applications.

The earliest passport applications and renewals date from 1870.

Over the years, the format of the passport changed a few times. The 1870-72 passport applications are in the

form of a bound ledger. The information includes name and surname, the son/daughter/wife of, age, destina-

tion, when issued, place of birth, residence, occupation, and remarks. (see fig. 1)

As noted in Part I, the 1872-86 passport applications are presumed lost or destroyed.

The 1886-1905 passports were baptismal certificates with handwritten brief information added, such as name

and surname, the son of, age, destination, when issued, place of birth, residence, occupation, and remarks (see fig 2).

Passports from 1906 to June 1915 were a one-page departmental form. (see fig. 3)

The photographs that had been included in passport applications after 1915 are a valuable resource for diverse observations. They reveal details on the class structure prevailing in Malta at that time. One can pinpoint working-class applicants not only from the clothes they were wearing but also from their expressions. They seemed uncomfortable taking a photo, probably for the first time. When a group of migrants went to the studio for a photo, some of them were so poor that they

had to borrow a tie and a polka (a golden chain with a watch) from the photographer. In one instance, a group of nine applicants wore the same loaned clothes. When the same applicant applied for a renewal of his passport some years later after a period of living abroad, one could notice a different set of better-looking clothes. Also, the occupation of the applicant could have changed, for example, from a field laborer to a farmer or miner.

The passport applications of families also provide interesting material for the researchers. In most cases the wife would be added to the application of her husband. There are instances of separate photographs, but also of family photographs attached to the applications. These types of data are of particular interest to social historians, genealogists and anyone else interested in the population and migration aspects related to Maltese history.

This was the biggest motivator to start the project on entering and providing the data from the passport applications to anyone interested, as the limitations in the human resources within the National Archives of Malta did not allow this task to be tackled internally. (To be continued.)



ALBERT EDWARD VELLA, 1942-2019 PERSONAL REMINISCENCES

I first got to know Albert at about the time he was retiring as chief representative and senior vice-president of the Bank of Valletta in Canada.

He and his gracious wife, Thérèse, often attended the dinner/dances of The Maltese Canadian Club of London and Albert never failed to bring a gift to be one of the prizes drawn later in the evening.

As an honorary member of our club, he received our newsletters and through them became aware of my interest in Maltese immigration to Canada, or at least

the London and Brantford, Ontario areas at the time.

About the autumn of 2010, Albert put me in touch with Dr. Maurice Cauchi of Australia, and Dr. Cauchi in turn introduced me to Mark Caruana, also of Australia. It was Mark who suggested I cast my net wider and consider the study of all the Maltese who immigrated to Canada. Eventually, I agreed and, a few years later, broaden my horizons to include all of North America.

Meanwhile, in October 2010, Albert invited me to Toronto to be interviewed for one of the Lehen Malti programs. The subject was my work with Mark Caruana in documenting all the Maltese immigrants to Canada.

At the same time Albert put me in touch with Mons. Phillip Calleja who was in the process of setting up the Migration Museum in Valletta. This, in turn led to me sending digital copies of the many immigrant photographs and other items I had in my possession and ultimately most of the newsletters issued by the London club.

Albert also introduced me to Claudia Caruana, the editor of the newsletter then produced by the Federation of Maltese Living Abroad (FMLA). This, in turn led to the submission of an article comparing the Maltese Canadian communities in Brantford to that of London, Ontario.

As the London club was winding up its affairs, in the latter months of 2018, Albert was one of those who encouraged my aspirations of putting out a free e-journal centering on the Maltese of all North America. In fact, he was the one who suggested and offered to do a running "Table of Contents" for *The Maltese Presence in North America*.

Albert and I last communicated by email on September 27th, when I was working on the October issue of this

journal and, knowing that his health had further declined, had written that I was familiar enough with his style for the “Table of Contents” and that I would take on the work of updating it. Albert’s last words to me were:

Dear Dan

I am afraid I am in the hospital and will be unable to help this month.

Best regards

Albert

The last time I saw Albert was at the Maltese community picnic for London and area, held in July 2019.

Some will recall the police drama series the *Naked City*, set in New York City, which was shown on television between 1958 and 1963. Each episode ended with the narrator intoning: “There are eight million stories in the naked city. This has been one of them.” So too, this has been but one of the countless stories which could be told of Albert’s benevolence and impact on communities and individuals throughout North America and beyond.

MALTESE-CANADIAN COMMUNITY LEADER ALBERT EDWARD VELLA: AN APPRECIATION

I recall meeting Albert Vella for the first time over 25 years ago during his short visit in Malta. I had just joined the Maltese Diplomatic Corps in 1994 and was about to depart to Australia to assume my first diplomatic post as First Secretary and Deputy High Commissioner of Malta to the Commonwealths of Australia and New Zealand and to The Philippines.

We had a long chat about Australia and the Maltese Diaspora. He offered his views on how best to deal with, work for and assist the Maltese community there. As a diplomat, I welcomed Albert’s many words of wisdom, kept them with me ever since and treasure them all my life.

For those who do not appreciate how important Albert was, not just for Maltese-Canadians but also for all Maltese around the world, which I call Global Malta, here is most of the work he did.

After concluding his studies at St. Aloysius College in Birkirkara, Malta, he was employed at the National Bank for 10 years. In 1969, he joined the Central Bank of Malta (CBM) and as Deputy Principal played a key role in the currency conversion to and implementation

of the Maltese Lira. He was appointed as the CBM's court expert in banking matters in a major fraud trail, which led to a successful prosecution.

In 1977, Albert immigrated to Canada, with a young family, and was employed in the financial services field, as Chief Auditor for Fidelity Trust Company, Vice President Accounting Control with Central Guaranty Trust Co. and with Sun Life Trust as Director Accounting Operations.

In 1990, he also set up AEV Consulting, a Management Consulting Company evaluating systems and accounting control issues. He served on the Ontario Securities Commission Roster for the Ministry of Financial Institutions assignment. In 1993, he was appointed Overseas Honorary Representative of the Malta Federation of Industry in Ontario, targeting business opportunities between Canadian and Maltese companies.

After immigrating to Canada in 1977, Albert occupied senior posts in the banking and financial industry. In 1993, he was instrumental in setting up the Bank of Valletta's Canada Representative Office. As the Chief Representative and Senior Vice President, he had the responsibility for banking compliance and regulatory extensive contacts in Malta and was instrumental in attracting companies to do business in Malta or companies that are now utilising Malta as a bridge to Europe and North Africa.

Albert was instrumental in organising trade missions from Malta to Canada and the United States. In 2002 he organised a seminar that focused on "Doing Business in Malta." The speakers included the Maltese Minister of Finance and the Governor General of the Malta Financial Services Authority. Albert actively participated in other trade missions that visited the United States in 2002 was the key speaker at the symposium "Canada Days in Malta" organised in Malta by the Canadian Embassy.

He retired in 2005 after 46 years in the financial services industry.

Albert Vella was one of the main pillars of the Maltese-Canadian Community for over four decades

Albert has been active in the Maltese community and was to the end, an Honorary President of the Maltese Canadian Association (Gozo), Honorary President of the Maltese Center in New York, Honorary Member of the Gozo Club, the Maltese American Community Club of Dearborn, the Maltese American Social Club of San Francisco, The Maltese Canadian Club of London, the *Għaqda Mużikali L-Isle Adam of ir-Rabat* and the *Socjeta' Filarmonika Nicolò Isouard of il-Mosta*. He was also the Founder, Past President and Honourary Life Member of the Maltese Canadian Professional and Business Association.

Albert was very active in fund raising activities for Dar tal-Providenza, Arka Foundation, Eden Foundation Gozo and St. Paul's Church in Toronto.

Specifically, at the Annual Bank of Valletta Concert the donations raised reached over \$105,000 (CAN.). For the Bank of Valletta Concerts, the Nicolò Isouard Band of il-Mosta was invited to Canada and the United States. The concerts were held under the patronage of distinguished guests, including the Prime Minister of Malta. Albert played a key role in fundraising for the Madonna Ta' Pinu project – a project spearheaded by Msgr Beneditt Camilleri. In conjunction with Prof. John Portelli, Albert was instrumental in launching the chair lift fundraising drive for St. Paul The Apostle Church Hall.

In 2006, he was awarded *Id-Dar tal-Providenza's Premju Monsinjur Azzopardi*, and in May 2010 coordinated the pastoral visit of Archbishop Paul Cremona O.P. to Canada and the United States.

Albert attended the IIIrd Convention for Maltese Living Abroad in the year 2000 and was a keynote speaker at the 2010 IVth Convention. He was the production editor of the Federation of Maltese Living Abroad (FMLA)'s newsletter *Maltese Link*, for its 15 issues, and Secretary of the FMLA for two years. He also led the FMLA as President.

Until the very end of his life, Albert was still active in the Maltese community including an interview segment (*Albert Vella Jitkellem ma...*) on the weekly Maltese national TV program, *Leñen Malti*. Having had to cut back, because of his failing health, he still held the post of Financial Administrator of the Leñen Malti Group.

It's always difficult to bid farewell a friend, a community leader and a giant who gave so much to the Community that was so dear to his heart. I pray, however, that what I wrote about him and Albert's departing, will spark the

much needed energy, vocation and vision that will enlighten more present and subsequent young leaders to lead Global Malta into the future.

MALTESE CHRISTMAS TRADITIONS REMEMBERED, CARRIED ON OR ALTERED IN LONDON, ONTARIO*

**This article is largely based on "Maltese Traditions at Christmas Time" The Maltese Canadian Club of London Newsletter, Issue 48 (November/December 2013), 16-18*

Houses in Malta are often decorated with *preseppi* (cribs) and *pasturi* (small plastic or clay images representing such figures as shepherds and angels). Large figures of *Il-Bambin Ġesù* (the Baby Jesus) are sometimes placed in front of windows or on balconies and are lit up at night. Houses are also decorated with Christmas wreaths, candles and all sorts of other decorations. Every household also has a Christmas tree decorated with light bulbs, tinsel and Christmas decorations.

Cribs were first introduced into Malta from Italy by rich noblemen. They were not popular at first and most were burnt. The first true Maltese crib is believed to have been made in Malta in 1617 and was displayed in the Dominican Friars Church in Rabat.

By the early to mid-20th century, cribs were thought of as old fashioned and not very popular anymore. To stop the decline of Christmas, in 1907, Father, now Saint, George Preca founded a children's charity and society called MUSEUM. In 1921 he started a tradition of having a Christmas Eve procession with a life size figure of the Baby Jesus being carried at the head of the procession.

The Maltese crib was influenced by its Sicilian counterpart where inexpensive figures (*pasturi*), made of Maltese clay, were mass produced. These *pasturi* came to show definite Maltese characteristics which were to single out the traditional Maltese crib from others.

What distinguished the traditional Maltese cribs themselves from others was that they were made in the form of caves from paper-mâché. The most popular material used, both before and after the Second World War, was a type of paper recycled from cement bags, brown paper, newspaper or any other type of discarded paper.

One of those born in Malta who has carried on this tradition of constructing a *preseppju* and decorating it with *pasturi* is Albino Ellul of the London suburb of Byron.

Lately, however, Albino has vastly expanded and altered this Maltese tradition.

It is a Maltese tradition to sow *ġulbiena* (vetch, canary seed known as *skalora*, alfalfa, wheat or other grain) on cotton beds in flat pans a few weeks before Christmas. These are left in dark corners in the house until the seeds produce white grass-like shoots. The pans with the fully-grown shoots are then used to decorate the crib or the statue of the Baby Jesus (*il-Bambin Ġesù*).

The late Fr. Henry Cassano of London recalled that when he was young, "We used to plant it on December 8th—the feast of the Immaculate Conception—and keep it in a dark place. It was watered every third or fourth day, until Christmas when it was put around the nativity scene. It stayed white...."

The late Frank Gatt remembered cotton and seeds being placed in shoe polish tins, water being added periodically and the tins being kept in the dark under the stairs.

Joe Martinelli says that November 25th, the feast of St. Catherine of Alexandria, was the date selected when he was a boy.

Albino Ellul grows his *ġulbiena* from *skalora*. Instead of shoe polish tins, he uses hospital pans and starts the process on December 1st.

JOHN GRIMA: A MALTESE EMIGRANT WITH A DREAM*

**This is Part I of a two-part article on the Maltese Canadian actor John Grima. I would like to acknowledge Mr. Grima's cooperation and assistance in my writing of this article.*

The United States may lay claim to the Maltese actor, Joseph Calleja, who was born in Rabat in 1897, but Canada can be equally proud of John Grima.

John Mary Grima was born in Rabat, on February 26, 1933, to Vincenzo Grima and Maria A. Debono, a block away from where Calleja was born. John Grima's ancestry can be traced back directly to about 1162 to one Ginaldo Grimaldi.

Young John was educated at the Mdina Boys' School and then attended the Hamrun Technical School. While at the latter, he was a member of the air scouts.

From before the age of seven, the young lad was "bitten by the acting bug." He was fascinated by theatre plays which used to take place at the St. Paul's Society-Count Roger Band, on Main Street, in Rabat. After first performing for the neighbourhood refugee children in his hometown during the Second World War John played "a couple of small parts" in school productions. As a teenager, he did his first stage performance at the Astoria Theatre in Rabat and later at the Radio City Opera House in Hamrun.

Obsessed with movies, he "practically lived at the Adelphi Cinema in Rabat. "California and Hollywood" became his ultimate goals.

John had a maternal great-uncle, John Maina, living in San Francisco and started to correspond with him. Maina, who had emigrated from Malta in 1921 as Giacomo Giordmaina, eventually agreed to sponsor his niece's son but, for young John, there was the question of finding the money for the passage to California.

In the meantime, as money started coming from "here and there" an opportunity arose to immigrate to Canada, a place John knew nothing about except it was closer to California than Malta. As the destination of the Maltese migrating to Canada seemed to be Toronto, 18-year-old Grima was determined to follow the herd.

His father had given his consent and on May 24, 1951, John sailed out of the Grand Harbour on board the Greek ship *Nea Hellas*. After disembarking from the ship on Friday, June 8th, he and his fellow Maltese emigrants destined for Canada, were met by Maltese Americans living in New York City and taken to the Maltese Centre in South Astoria to be entertained for the day. Later that night, they returned to Jersey City, NJ to catch their train and arrived in Toronto the following day.

John was supposed to have been met at Union Station by Mannie Mifsud, but his friend from Malta got the day mixed up. Instead, John, like others, having nowhere to go, went by truck to the former World War II camp in Ajax. There he spent the weekend.

Eventually, he and Mannie met up and John later became acquainted with the half-brothers Freddie Attard and Joseph Gatt. Unbeknownst to John, he and

Freddie had come over on the same ship in June!

Joseph had arrived later that month. The four young men then rented a big room near Queen Street and Spadina Avenue.

John was able to pick up a few jobs as he waited for his sponsorship papers from his great-uncle in San Francisco.

Meanwhile, one Sunday evening, a few months later, an English acquaintance of one of John's friends came over and "had a wallet full of photos of Canadian girls." The other three were looking at the photos but when John went to look the visitor took him aside and told him that he had a particular photo of a girl who would be the one for him.

Before he knew it, John was making a date to meet this young woman whose name was Edith Porteous, a native Torontonian. John soon fell in love with her, ignored the sponsorship papers when they finally arrived and, on September 1953, he and Edith were married. The young couple settled in Toronto's east end.

Previously, John had met Vincent Baldacchino and boarded with him in a rented room on Wellesley Avenue, near Church Street. Meanwhile, he worked for a year for the moving company of M. Rawlinson Limited. To somewhat satisfy his passion for acting and Hollywood, John ushered at a local theatre in his after hours.

After marrying, he moved farther east, to around the Broadview area, and worked for the City of Toronto Parks Department.

John also attended a vocational school for six months and a commercial arts evening school, but the "acting bug" continued to grow stronger and stronger and he was not content with the jobs he had been working at in Toronto.

He decided, in 1956, to visit his great-uncle in San Francisco for a few weeks. While in California he went to Hollywood but soon realized he did not have "any experience or training" for acting in the movies. Nor did he have an opportunity to meet his fellow countryman, Joseph Calleja, while there.

Although he now had a wife and two sons, Johnny and Victor, John was determined to attend an acting school on his return to Toronto.

He enrolled at the Jack Medhurst Acting School for a four-year course. His tutor, Jack Medhurst, realized John's potential and he was immediately cast in main roles in the plays performed at the academy. These included Romeo in *Romeo and Juliet*, Macbeth in *Macbeth*, Hamon in *Antigone* and the father in *Beauty and the Beast*.

In the course of his studies he received two scholarships.

John made his professional acting debut in 1957 at the

Crest Theatre in Toronto in Shakespeare's *King Lear*.

THE MALTESE CANADIAN DISPLAY CASE AT THE MIGRATIONS MUSEUM

Some years ago, Richard S. Cumbo of Toronto was asked by Emigrants Commission Director Father (now Monsignor) Alfred Vella to raise funds for a Maltese Canadian monitor and display case at The Migration Museum housed in Dar I-Emigrant, Castille Palace, Valletta.

Recently, Richard Cumbo had the nameplate (seen below) engraved for the display case.



As it turned out, the entire sum for the display case was donated by Joseph Giordmaine and his wife Mary of Princeton, NJ.

Joe Giordmaine, before his retirement, was a physicist who studied lasers, optoelectronics, optical physics and nonlinear optics.

He was born in Toronto, ON in 1933 and earned a bachelor's degree from the University of Toronto in 1955 and a master's degree and a doctorate from Columbia University in 1957 and 1960 respectively.

The Gordmaines donated the display case in memory of Joe's father Johnny Giordmaine.

Born in St. Paul's Bay, Malta, John Nicholas Giordmaina was trained in electrical engineering and had immigrated to Toronto in 1919 where he pursued this trade.

His primary interest, however, was magic and in 1930 he set himself up as a professional entertainer. It was also at this time that he slightly modified his surname from Giordmaina to Giordmaine, thereby rendering it easier for English-speaking people to pronounce.

Known as the Little Leger Demoniak, the Diminutive Dynamic of Deception, the Gay Magician and the Maltese Houdini, he entertained prime ministers, governors and presidents' wives and appeared many times on *The Ed Sullivan Show*, but his special love was entertaining children.
